The exhibit fee will be a flat rate of \$2,000. Exhibit times will be as follows:

Sunday – Setup at Noon,

Monday – Thursday: from 6:30 a.m. until 10:00 a.m. and from 4:00 p.m. until 6:30 p.m.

Each exhibit will have one skirted table. The exhibit hall will be located in the Jefferson Room which is adjacent to the Ballroom where the lectures will be taking place. This year we are continue using an exhibitor card. The attendees will receive a card that is to be signed by one of the representatives from your table. These cards will be used in a drawing for door prizes for the attendees.

Dress for exhibitors will be casual. Sweaters and ski wear will be appropriate. We would discourage suits and dresses. Participants will be following this as well.
