Exhibit times will be as follows:

Sunday – Setup begins at 3pm

Monday – Thursday: the exhibit room will be open from 7:00 a.m.- 10:00 a.m. and from 4:00 p.m. - 6:30 p.m.

Over the course of the four days, you will have an opportunity to visit with all of the attendees.

Monday evening there will also be a welcome reception from 6:45 p.m. – 8:30 p.m. During this time the exhibit hall will be open and the attendees, as well as their families, will be enjoying a wonderful evening reception. This is an excellent opportunity to visit with the physicians when they are not attending lectures.
