

<u>Current Position/Practice Location</u>: I retired from my geriatric medicine practice at Sanford Health in Fargo in 2020 just before the Covid-19 pandemic began. As an advocate for age-friendly care for older adults I volunteered and served on the North Dakota Medical Association Covid-19 Physician Advisory Group and the American Medical Directors Association (AMDA) Covid-19 State Task Force. In 2021 I was appointed to the AMDA State Based Policy & Advocacy Subcommittee. I am also a member of the Maricopa County Department of Public Health Medical Reserve Corps and serve as a volunteer vaccinator in Arizona.

<u>Family</u>: My husband Roger Grimm and I reside in Fargo ND and enjoy time away in the winter in Arizona. I have 3 stepdaughters and 4 grandchildren and one great grandchild. I also enjoy reading, cooking, walking, yoga, golf, and travel.

## **Family Medicine Questions:**

- <u>Why did you choose Family Medicine?</u> As a student I struggled to choose a specialty as I liked all my rotations. I chose a rotating internship and then did general practice in Casselton ND for three years. I realized that I loved the variety of patients and completed a family medicine residency. My focus and passion changed to caring for older adults after completing a mid-career geriatric fellowship.
- 2. Who is someone along your path that inspired you and why? As a young physician in Casselton in the early 1980s I met Dr. Bob Geston who practiced for many years in West Fargo. Bob became a mentor and encouraged me to get involved in the state medical association political action committee. I've been involved in health care advocacy ever since. As the Covid 19 pandemic evolved and North Dakota led the nation in nursing home COVID19 deaths per capita I observed that the health department struggled to

reach nursing home medical directors to quickly communicate infection control practices, testing measures, and visitation guidelines as there was no public listing of medical directors. I assembled a coalition of stakeholders and North Dakota became the first and only state to accomplish the goal of a public medical director registry. 3. <u>What advice would you give to a young physician starting out?</u> Use your voice in your community! We are content experts and patients respect us and look to us for guidance. This became particularly important during the pandemic public health emergency with the associated widespread disinformation.
